Principal activity

The principal activity of the company is the provision of financial services.

Going concern

The financial statements have been prepared on a going concern basis.

As set out in the Statement of Director's Responsibilities, in preparing these financial statements the director is required to prepare the financial statements on the going concern basis unless it is inappropriate to presume that the company will continue in business.

The directors of the parent company have considered in detail the Group's forecast performance, as well as its capital and liquidity resources which are available to all of its subsidiaries. The Group's funding facilities were renewed in 2010 until July 2015 and on this basis the directors have a reasonable expectation that, despite uncertain market conditions, the Group has sufficient funding and liquidity facilities to ensure that the company will continue in operational existence for the foreseeable future. Accordingly the directors of the company have adopted the going concern basis in preparing the financial statements.

Directors' liabilities

Enhanced indemnities are provided to the director of the company by Chartis Insurance UK Limited against liabilities and associated costs which he could incur in the course of his duties to the company. All of the indemnities remain in force as at the date of this Report and Accounts. A copy of each of the indemnities is kept at the registered office address of the company.

This confirmation is given and should be interpreted in accordance with the provisions of s418 of the Companies Act 2006.



Statement of Directors' Responsibilities

The directors are responsible for preparing the Directors' Report and the financial statements in accordance with applicable law and regulations.

Company law requires the directors to prepare financial statements for each financial year. 

1 Accounting policies

The following accounting policies have been applied consistently in both the current and preceding year.

Basis of preparation

The financial statements have been prepared under the historical cost convention and in accordance with applicable law and United Kingdom accounting standards.

Exemption from preparing a cash flow statement

The company is exempt from preparing a cash flow statement as 90% or more of the voting rights are held within the group. Consolidated financial statements including the company are publicly available.

Going concern

The financial statements have been prepared on a going concern basis.

As set out in the Statement of Director's Responsibilities, in preparing these financial statements the directors are required to prepare the financial statements on the going concern basis unless it is inappropriate to presume that the company will continue in business.

The directors of the parent company have considered in detail the Group's forecast performance, as well as its capital and liquidity resources which are available to all of its subsidiaries. The Group's funding facilities were renewed in 2010 until July 2015 and on this basis the directors have a reasonable expectation that, despite uncertain market conditions, the Group has sufficient funding and liquidity facilities to ensure that the company will continue in operational existence for the foreseeable future. Financial instruments

Financial instruments are classified and accounted for, according to the substance of the contractual arrangement, as financial assets, financial liabilities or equity instruments. An equity instrument is any contract that evidences a residual interest in the assets of the company after deducting all of its liabilities. Where shares are issued, any component that creates a financial liability of the company is presented as a liability in the balance sheet. The corresponding dividends relating to the liability component are charged as interest expense in the profit and loss account.

2 Profit and Loss account

As the company has not traded in the current year or preceding year no profit and loss account has been presented.

3 Audit Fees

The audit fees of £1,000 (2012 - £1,000) have been borne by the parent undertaking and not recharged during the current or preceding year.
