### 1 Accounting Policies

#### Basis of measurement and preparation of accounts

The accounts have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities effective April 2008.

#### Turnover policy

Turnover, which is stated net of value added tax, represents amounts invoiced to third parties. Turnover is wholly attributable to the company's principal business activity, entirely within the United Kingdom.

#### Tangible assets depreciation policy

All fixed assets are initially recorded at cost. Depreciation is provided on all tangible fixed assets at rates calculated to write off the cost or valuation, less estimated residual value based on prices prevailing at the date of acquisition or revaluation, of each asset evenly over its expected useful life as follows:

Plant & equipment - 10% reducing balance  
Fixtures & fittings - 15% reducing balance
