Advances to Directors

During the year £141,696 was advanced to a director and £134,338 was subsequently repaid. The balance owed by the director at the beginning of the year was £55,553 and the balance owed by the director at the end of the year was £62,911. This loan was interest free when in credit, and bore interest at the HMRC official rate of 2.5% when in debit. The loan was unsecured and there are no fixed repayment terms.
