#### **NOTES TO THE FINANCIAL STATEMENTS**

#### 1. AVERAGE NUMBER OF EMPLOYEES

The average number of employees during the year was NIL (2020 - NIL).

#### 2. DIRECTORS' ADVANCES, CREDITS AND GUARANTEES

The company has six directors. All are unpaid, all are shareholders or immediate family members of shareholders, and all are leaseholders or immediate family members of leaseholders where the company is now the lessor. (These leases were struck with the previous owner of the freehold but novated to the company upon its purchase of the freehold.)

As with non-director shareholders, directors contributed capital and made loans to the company to enable the company to purchase the freehold. A single formula was applied to the particulars of each underlying lease. Ground rents were discounted at 8%; the reversion value at lease expiry, at 5%. The freehold's control premium, legal fees and expenses, and the VAT were divided equally among the original eleven shareholders. One of the directors performed these computations.

The company is entitled to exemption from audit under Section 477 of the Companies Act 2006 for the year ended 31 March 2021.

The members have not required the company to obtain an audit of its financial statements for the year ended 31 March 2021 in accordance with Section 476 of the Companies Act 2006.

The directors acknowledge their responsibilities for:

- (a) ensuring that the company keeps accounting records which comply with Sections 386 and 387 of the Companies Act 2006 and
